

W-8BEN 表格填写说明

美国证券市场几乎对全世界国家的人民开放，为奖励投资，符合外国人身份的投资人买卖证券所得之资本利得(Capital Gain)免于扣缴美国所得税。若您并非美国居民，开户时请填写美国国税局提供的 W-8BEN 表，以便享受免税优惠。然而，外国投资人所得的现金股利 (Dividends) 仍然必须缴交美国政府所得税。W8BEN 表请寄到第一理财而非美国国税局。

W-8BEN 是美国政府单位发行的表格，必须以英文正楷填写，第一理财所提供的中文版本，仅作参考用。**此表格不可传真或扫描，请务必邮寄正本至第一理财。**

请注意：

- 美国公民、持有绿卡之永久居民请勿使用 W-8BEN，请使用 W-9。
- 居住在美国境内之外籍人士，其身份符合美国国税局所定义之所得税申报义务人者，请勿使用 W-8BEN，请使用 W-9。
- 当年度在美国境内实际居住超过 183 天之外籍人士，请勿使用 W-8BEN。F、J、M、Q 签证持有者除外，请在表格上註明您的签证类别。
