

# W-8BEN 表格填写说明

美国证券市场几乎对全世界国家的人民开放,为奖励投资,符合外国人身份的投资人买卖证券所得之资本利得(Capital Gain)免予扣缴美国所得税。若您并非美国居民,开户时请填写美国国税局提供的W-8BEN表,以便享受免税优惠。然而,外国投资人所得的现金股利 (Dividends) 仍然必须缴交美国政府所得税。W8BEN表请寄到第一理财而非美国国税局。

W-8BEN 是美国政府单位发行的表格,<u>必须以英文正楷填写</u>,第一理财所提供的中文版本,仅作参考用。**此表格不可传真或扫描,请务必邮寄正本至第一理财。** 

## 请注意:

- 美国公民、持有绿卡之永久居民请勿使用 W-8BEN,请使用 W-9。
- 居住在美国境内之外籍人士,其身份符合美国国税局所定义之所得税申报义务人者,请勿使用 W-8BEN,请使用 W-9。
